## European Beach Handball Tour 2021/22 - National observer nomination

Dear beach handball friends,

The ebt season 2021/22 officially started on 1<sup>st</sup> November and we kindly ask all National Federations to announce maximum 10 national observers, who shall take over the function as ebt observer during the ebt season 2021/22.

An ebt observer can be:

- EHF Beach Handball Commission member
- EHF Beach Handball delegate
- National observer nominated by the National Federation (ONLY in case no EHF delegate is present)

Each national member federation is therefore kindly requested to nominate persons, who can take over the role as a national observer at ebt tournaments for the current season.

The national observers from the last ebt season may be re-nominated or replaced, or additional national observers (max. 10 persons in total) might be added, but a feedback needs to be provided to EHF in order to confirm the list of national observers for each federation.

When re-nominating national observer(s) of last season please check the data provided (email, mobile number, date of birth and function within your federation) and inform the EHF office of any changes together with the confirmation of the list of persons.

Please see here the **requirements** for a national observer:

- Member of the National Federation (no club representatives or private persons)
- Good knowledge of beach handball and the ebt regulations
- Good English language knowledge (able to report to the EHF office, etc.)
- Basic IT knowledge and able to use the needed internet platforms
- Reliable and neutral
- Readiness to attend national ebt tournaments (presence from the first until the last day)
- No involvement in the organisation of the respective tournament (organiser, referee or player)
- · Accommodation in a single room during the tournament arranged and paid by the organiser

The **tasks** of a national observer are:

- Participate in an ebt tournament (upon invitation and nomination via the ebt website by the organiser).
- Check the draw of the groups and the tournament criteria at the venue.



- Enter the final criteria and final ranking of the tournament (by using the EHFamily portal) within 3 days from the end of the tournament at the latest.
- Take and save a sufficient number of pictures proving the realisation of the published criteria (to be saved until the end of the running season).
- Send an <u>obligatory written report</u> (+ pictures) with details, <u>the list of the EHF Officials</u> and the <u>list of players per team</u> (first name, last name, nation, birth date) who attended the tournament within three (3) days after the end of the tournament, to the EHF Office (ebtreports@eurohandball.com)
- Inform the EHF about any disciplinary matters or violations of the valid ebt regulations.

National observers/EHF beach handball delegates present without any clear assignment, or failing to fulfil their duties, will be reported and a respective proceeding will be initiated in accordance with the EHF Legal Regulations.

EHF Beach Handball delegates are automatically in the ebt observer list. EHF Beach Handball referees have to be nominated by the national federations as national observers and are not allowed to act as referees, when nominated as ebt observer.

Please nominate suitable persons within your federation, who are able and willing to take over the tasks and fulfil the listed requirements.

A feedback regarding the national observer needs to be returned to the EHF Office (johnson@eurohandball.com) by **23 December 2021** at the latest. Otherwise the current list of national observer will be deleted from the list for the current season.

After the second deadline on **25 February 2022** no national observer can be added for the current ebt season.
